

UKC Regulations for Agility/Obedience Trials: Dogs shall be moved up to an higher class
at the request of the owner, as a result of qualifying for an Agility/Obedience Title,

provided that the request is made to the Trial Secretary not later than the day preceding the event. Such move-ups entries shall be accepted subject to the availability of the class and if the club has allowed move-us. Dogs so moved up will be entered at the end of the running order. Entry move-up valid only if the dog was already entered at the Event and only if approved by the Trial Secretary.

All awards and prizes must be claimed during the Trial – none will be mailed or shipped.

Dogs may arrive any time prior to their scheduled time of judging (BE SURE YOU HAVE CHECKED-IN AT THE PROPER TIME FOR YOUR CLASS). Exhibitors alone are responsible for the presence of their dogs in the judging ring when their numbers are called to be judged. Dogs not required for further judging are excused.

All dogs must be on leash at all times when not in the ring. At the handler's option, the dog may wear a flat buckle or quick release collar without tags or other attachments. Nameplates are not allowed on any collar. *Pinch collars, and electric collars are not permitted*. Choke collars are permitted in the Obedience ring. No toys, food or training devices of any kind are permitted in the ring. Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

Note to Exhibitors:

"Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

Additionally, exhibitors are required by Iowa State health requirements to maintain proof of rabies vaccination.

OBEDIENCE CLASS "A" IS FOR ANY DOG AND/OR HANDLER WHO HAS NOT COMPETED IN ANY VENUE OR EARNED AN OBEDIENCE TITLE.

RALLY OBEDIENCE CLASS "A" IS FOR ANY DOG AND/OR HANDLER WHO HAS NOT EARNED A UKC RALLY OR TRADITIONAL OBEDIENCE TITLE OR IT'S EQUIVALENT IN ANOTHER VENUE.

Eligible Dogs: This trial is open to all dogs 12 months of age or older that are registered with the United Kennel Club or that have UKC Limited Registration (ILP) and as stated in the UKC Rules for Dog Shows. **Entries close day of show or when filled**, after which time entries cannot be accepted, canceled, altered, or substituted except as provided for in the UKC Rules for Dog Shows.

Confirmation of entry will be sent by e-mail (if included with registration) after pre-entry closing date. (10/23/09)

Refunds will be given for bitches that come in season after the closing date of the trial minus \$5 handling fee with a vet's certificate prior to start of show. All requests must be in writing. Other requests will be on a case-by-case basis minus \$5 handling fee. **No Refunds** will be given in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee. If, because of riots or civil disturbances or other acts beyond the control of the host club, it is impossible to open or to complete the trial, no refund of entry will be made.

Move-ups must be in writing using the move-up form included in this premium or on the web site, and may be mailed or e-mailed to **johnnetteulch@netins.net**. Move-ups for Friday will not be accepted after 5:00 p.m., Tuesday, October 27, 2009. Move-ups for Saturday and Sunday will be accepted in person at the trial site before 7:30 a.m.

Same day entries will begin at 9:00 a.m. on Friday, October 30, 2009. Same day entries for Saturday will begin at 7:00 a.m. Same day entries for Sunday will begin at 7:00 a.m.. Judging will begin not earlier than 10:00 a.m. on Friday and 8:00 a.m. on Saturday and Sunday.

- All entries must be submitted on the current "Official UKC Entry Form". You may use one entry form to enter the same dog in more than one event on the same weekend.
- 2. Use separate entry form for each dog to be entered in a club's event.
- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at <u>www.ukcdogs.com</u> or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified.
- Obedience Trials, Agility Trials and Weight Pull events and Dog Sport Trial events are open to all UKC recognized breeds and mixed bred dogs with a valid Limited Privilege number.
- Obedience only: Check the box provided to request either the Veteran or Special Jump height option. Veteran dogs must be 8 years or older. Eligible dogs for Special Jump Heights are outlined in the current rules and regulations.

We want you to keep the points earned at licensed UKC events.

Important things to remember

- All dogs entering UKC events must be permanently registered, have valid Temporary Listing Number, or a Limited Privilege number for performance events.
- All entry forms must be complete and signed. Incorrect information submitted on the entry form may invalidate your wins.
- To be eligible to enter into the Breeder/Handler class, you must be one of the breeders of record, or a member of the immediate family of one of the breeders of record. Immediate family includes spouse, parent, stepparent, child, stepchild, brother or sister.
