A fee of \$25.00 will be levied for a returned check . All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. FAX'd entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

What is Iowafest?

Participating clubs will award free entries to all nine fall 2012 Iowa UKC obedience trials to the handler of the dog with the highest aggregate score accumulated during their fall trials in 2011. An award for each level (Novice, Open and Utility) will be presented.

How can I participate?

No registration is necessary. A dog need not be entered in all nine trials to win, however, the more trials entered, the more possible qualifying scores, the higher the potential aggregate score. Trial secretaries will submit all qualifying scores from their trials to Lorelle Jones of K9 Sports Club.

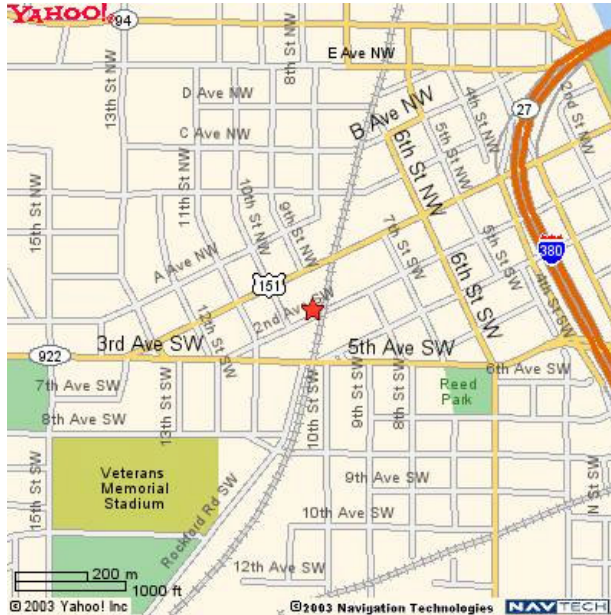

UKC Regulations of Obedience Trials: Dogs shall be moved up to a higher class at the request of the owner/agent, as a result of qualifying for an obedience title, provided that the request is made to the Trial Secretary not later than the day preceding the event. Such move-up entries shall be accepted subject to the availability of the class and if the club has allowed move-ups. Dogs moved up will be entered at the end of the running order. Entry move-up valid only if the dog was already entered at the event and only if approved by the Trial Secretary.	

Driving instructions from the North:

Take I-380 from the North to Cedar Rapids. Take exit 19B towards Veterans Memorial Stadium/1st Avenue West. Turn right onto 1st Ave. Turn left onto 10th Street and the building is located on the corner of 10th and 2nd Ave.

Driving instructions from the South:

Take I-380 South. Exit at exit 19A Diagonal Drive. Take a slight left onto 3rd Street and turn left onto 5th Ave. From 5th Ave turn right onto 6th Street SW and left onto 2nd Ave. Building is located on 2nd Ave. and 10th Street.
