HOW TO USE THIS ENTRY FORM:

1. Individual element classes are divided into "A" and "B" sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching elements chosen.

Entries

1. All entries must be submitted on the current "Entry Form". You may use one entry form to enter the same dog in more than one activity in the same weekend.
2. Use a separate form for each dog entered in a club's events.
3. Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified. Make checks payable to the host club.
4. Nosework events are open to all recognized breeds and mixed-breed dogs with either a limited privilege or indefinite listing privilege number.

WAIVER

All events are held under the Official Rules and Regulations of the UKC. Absolutely no alcoholic beverages, illegal drugs, or firearms (unless you are authorized to carry) will be allowed on the grounds or in the buildings on the day of a UKC Licensed event.
