Pre-entries will be accepted on a "first received" basis
Pre-entries will close **Friday, May 8th** after which time you must enter day of trial.

Entries close day of trial for both Obedience and Rally Trials at 8:00 AM or when entry limits have been reached, at which time entries cannot be accepted, canceled, altered or substituted except as provided for in UKC Dog Show Rules. **Judging begins at 8:30 AM all three days.**

A fee of \$25.00 will be levied for a returned check . All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. FAX'd entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.
